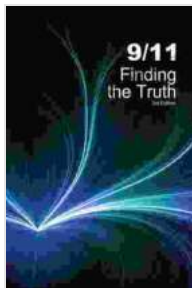


9/11 Finding the Truth: Andrew Johnson's Perspective

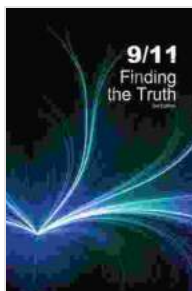
